Club Administrator Report

Patrol Director Position

Question: Does it make sense for Kenny to remain Patrol Director in addition to being the full-time administrator? Consensus: Move to separate the position based on finding the right person and not a time frame. Goal: have the process in motion for the season kick-off. Charge the Patrol Committee with coming up with a plan for managing the transition.

Lory State Park Skills Area Update

Initial walk-through and planning with the initial stakeholder meeting for the revamped skills area completed including strategic plan for implementation and gaining funding. Initial estimate of \$95K project cost. Action item: email Monty to get story to Christy to include in email newsletter.

Back-up Action item: announce we are looking for a race director in newsletter, Facebook, Twitter.

Off-Season Events:

Ideas: night riding clinic, holiday party, expert level clinic, suspension set-up clinic, movie night showing "Unreal" and a few others (Lyric? Lincoln Center?).

Suspension set-up clinic is in motion.

Action item: Andy approaching people to take on coordinating the events.

Pete and Jon to meet with Rock-On-Wheels for Overland MTB journalism exposure.

Question: does it make sense to recruit an event coordinator? Consensus: no. Kenny would be a resource keeping track of what is in motion so events don't overlap and/or fall through the cracks.

Action item: ask Kenny to help send reminders seeking stories from events and committees to pass along to Christy for the newsletters.

Additional Items:

Consider what is our official stance on support for injured/in need community bike riders, and would this differentiate from our official stance for injured/in need club members? **Action Item: discuss at second December meeting, form club policy.**

MTBtime:

Partnership to help promote mountain-bike geared local businesses to advertise with our partner. Perhaps sponsor advertising space on behalf?

Action item: ask Kristin to come in and explore this further.
